Avantis Marine Limited acknowledge that we have an impact upon the environment through the expending of finite natural resources, the creation of waste, through our operational carbon emissions embedded within the products that we sell.

We also recognise that our impact goes beyond the operations within our business, during which time we are the custodians of the resources in our care. We hold an indirect responsibility for the resources used in the supply chain upstream from our operations and for the resources expended during the life cycle of our products downstream of our operations, along with our repair and maintenance services, after they become the care of others.

Furthermore, we recognise that we have a responsibility to assist our clients with the reduction of their emissions through the optimal performance of our products and to drive our supply chain to reduce their emissions.

We are committed to reducing our environmental impact, by reducing the resources that we use in our operations, (energy, materials, and water) and adopting circular principals to optimise material use and minimise waste.

We have set a net zero target of 2030, which will include all direct emissions that we as a business have control over (including energy consumption, business travel, water usage and waste production). We will utilise an energy and waste tracker to make sure that we are as accurate as possible we can then track our progress and the drive towards ourselves meeting that strategic target.

The key greenhouse gas emissions are carbon dioxide, methane and nitrous oxide hydrofluorocarbons, perfluorocarbons, and sulphur hexafluoride. Each gas has a different capacity to cause global warming. Carbon dioxide is expected to be responsible for about two thirds of the anticipated future warming.

The impact of climate change is driving the expectations and ambitions of our customers and our employees. As an ethical and sustainable business, whose business model is wholly reliant on the environment being at the leading edge of carbon reduction is a key objective within our goals and is fully supported from the top to the very bottom of our organisation.

We recognise that a stretch target is one that we cannot achieve simply by working a little harder or a little smarter. To achieve this target, we will require a top to bottom review of our business. We will have to invent new strategies, new incentives, and entirely new ways of achieving this ambitious target.

We commit to achieving net zero emissions before 2035 and going beyond that thereafter.

We will align and look to demonstrate industry best practice, recognising the science, the evidence, the law. UK Government and our clients own net zero targets if it is accelerated due to any of the aforementioned considerations.

As a best practice employer, we value our staff highly. We will encourage them and support them in our organisations goals to reduce our impact upon the environment and we will reciprocate by encouraging and supporting them to reduce their own personal impact upon the environment outside of work. We will them in using sustainable means of transport to and from work, and in more in their daily lives.

As a company, we hold our environment as one of our most treasured assets and the onus lies with us to protect it.

The Managing Director will review this policy annually, and revise or update it as necessary.
